ORDERS BY THE GOVERNOR NOTIFICATION EXECUTIVE ORDER

Dated Dispur, the 30th September, 2013.

No. SWD. 293/2004/49: The Governor of Assam is pleased to make the following orders further to amend the Assam Social Welfare (Recruitment and Promotion) Service Orders, 1994, hereinafter referred to as the principal Orders, namely:-

- Short title and commencement . 1. (1) These orders may be called the Assam Social Welfare (Recruitment and Promotion) (Amendment) Service Orders, 2013
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Amendment of clause 5.

- 2. In the principal Orders, in clause 5, -
 - (i) in sub-clause (c), after the word "Commission", the words "and by promotion" shall be inserted;
 - (ii) after the existing sub-clause (c), the following new sub-clause (d), (e) and (f) shall be inserted, namely:-
 - "(d) (i) 60% shall be filled up by Direct Recruitment through A.P.S.C;
 - (ii) 40% shall be filled up by promotion from the Assistant Child Development Project Officer (ACDPO)/ Supervisors / Assistant Superintendent Home and allied cadres/ Statistical Assistant / Field Investigator / Ministerial Staff of Directorate and their individual percentage will be as follows:-
 - (a) 34% shall be filled from ACDPOs/ Supervisors (till the posts of ACDPOs are abolished, promotion is to be made from ACDPOs and once abolished, promotion is to be made from the cadre of Supervisors on Seniority basis);
 - (b) 4% shall be filled from Statistical Assistants:
 - (c) 0.4% shall be filled from Assistant Superintendent Home and allied cadres;
 - (d) 0.8% shall be filled from Ministerial Staff of Directorate; and
 - (e) 0.8% shall be filled from Field Investigator;
 - (e) Seniormost CDPO and allied cadre officers shall be eligible to hold the post of District Social Welfare Officer; (f) A candidate for appointment as DSWO/CDPO/allied cadre shall have the minimum qualification of a graduate in Arts, Science or Commerce from a recognized University and in addition, any one of the following qualifications:
 (a) Post Graduate Degree or Diploma in Social Works/Labour and Social Welfare/ Sociology/ Anthropology/ Criminology, or

- (b) Graduate in Child Development / Home Science / Nutrition, or
- (c) Graduate have Philosophy / Education with Psychology, Economics."

Amendment of Annexure-I.

3. In the principal Orders, in Annexure- I, in serial No. 3, provision in Column No. (6), shall be omitted.
