Deputy Commissioner for Persons with disabili-
ties in the district to access the facilities
of grievances of the persons with disabilities
and for redressing the grievances of the
persons with disabilities in district level.

Sir,

I am directed to say that, as laid down under section 60 of chapter XII of the Persons with Disabilities (Equal Opportunities, Protection of Rights and full Participation) Act, 1995, the State Govt. of Assam has appointed one senior Officer of Assam Civil Services as Commissioner for Persons with Disabilities, Assam to look in^{to} the grievances of the persons with disabilities as well as for redressing the grievances of the persons with disabilities with the head quarter at Guwahati.

As the persons with disabilities in the district level find it difficult to access all the facilities of grievances for redressal at the State capital at Dispur, it is therefore decided to declare the district Deputy Commissioners as also Deputy Commissioner for Persons with disabilities in all districts for redressing the grievances of persons with disabilities in their respective districts henceforth.

All Deputy Commissioners of Dists. are therefore directed to act accordingly keeping in view Co-ordination with Dist. Social Welfare Officer of the Districts.

This issues with the approval of Judicial Dept t. Govt. of Assam, and State Chief Secretary, Assam.

This will come into force from the date of issue of this order.
