Sir/Madam,


I am directed to say that the Government has agreed to merged the existing three Centrally Sponsored Schemes namely Special Central Assistance to Scheduled Castes Sub-Plan(SCA to SCSP), Babu Jagjivan Ram Chhatrawas Yojana(BJRCY and Pradhan Mantri Adarsh Gram Yojana(PMAGY) into a single scheme namely Pradhan Mantri Anusuchit Jaati Abhyuday Yojana(PM-AJAY) for implementation till 31.03.2026.

2. Subsequent to their merger, these three schemes would now be implemented as components of the merged scheme of PM-AJAY. In order to have a better implementation of this scheme, a consolidated guideline for implementation of merged scheme of PM-AJAY has been finalized and being sent herewith for information and necessary action at your end.

3. For better implementation and monitoring of the scheme, a dedicated web portal has also been developed as <https://pmajay.dosje.gov.in> and put in place. It is requested that this may be brought to the knowledge of all concerned.
