SJED/E-280260/55: In exercise of the powers conferred by Section 14 of the Rights of Persons with Disability Act, 2016, the Governor of Assam is pleased to designate the Deputy Commissioner of each district as Designated Authority to provide further support of a limited guardianship to take legally binding decisions on behalf of Persons with Disabilities in consultation with such person, who had been provided with adequate and appropriate support but is unable to take legally binding decisions.

The Designated Authority shall exercise the powers and functions in conformity with the provisions laid down in Section 14 of the Rights of Persons with Disabilities Act, 2016.
