Nomination against SI No. 6, 11 and 12 will be done by the Chairperson. The Chairperson may invite any other person(s) as expert(s) as deemed fit.

**Functions of the Committee:**

The District Level Committee on disability shall perform the following functions namely:-

1. Advise the District authorities on matters relating to rehabilitation and empowerment of persons with disabilities.
2. Monitor the implementation of the provisions of the Act and the rules made there under by the District authorities.

3. Assist the District authorities in implementation of schemes and programmes of the Government for empowerment of persons with disabilities.
4. Perform as district level authority for appointment of limited guardianship for persons with disabilities as provided in rule 8 of the Assam State RPwD Rules.
5. Look into the complaints relating to non implementation of the provisions of the Act by the District authorities and recommend suitable remedial measures to the concerned authority to redress such complaints.
6. Look into the appeal made by the employees of Government establishments aggrieved with the action taken by the District level establishments under sub-section (4) of section 23 of the Act and recommend appropriate measures.
7. Hold minimum of one meeting in a month.
8. Submit progress reports to the Social Justice & Empowerment Department for action taken in every month in Form X.
9. An Assessment Board shall be formed with the following members, namely,-
  - i. The Joint Director Health Services of the District or his representative not below the rank of Senior Medical and Health Officer – Chairman
  - ii. One Social Worker or representative of a registered organization under the Act – Member
  - iii. District Social Welfare Officer or his or her representative – Member Secretary.
10. Any other functions as may be assigned by the State Government.
