Discontinue of holding interview for Grade-III & Grade-IV post and

Sir,

I am directed to say that some of the Departments have referred the matter regarding to discontinue the interview in terms of the Government decision communicated vide letter cited above under reference. Some of the Appointing Authorities have made advertisements *inter-alia* specifying the manner of recruitment process prior to the issue of Govt. instructions No.ABP.70/2016/2 dated 25-05-2016 and conducted written test but interview is yet to be held pursuant to the terms of the advertisement. Further, some Department's might have issued advertisement but written test is yet to be held.

Government after careful consideration of the matter and taking into the account of the views of the Judicial Department, has decided to lay down the following guidelines in the matter of recruitment of Grade-III & Grade-IV posts.

- 1. If the written test is already completed pursuance to the terms of advertisement prior to 25-05-2016 but interview is yet to be held, such process shall continue and has to be concluded in accordance with the advertisement.
- 2. The provision of existing Service Rules regarding the manner of recruitment shall be followed till relevant amendment is made and even any amendment now would not effect the recruitment process already commenced in terms of relevant Rules/Orders. All Departments may take necessary action for suitable amendments of the Service Rules accordingly.
- 3. If any advertisement is made specifying therein to hold written test and interview but the written test is yet to be held, such advertisement may be modified provided it does not conflict with any provision of Rules/Orders.

All Administrative Departments are requested to bring it to the notice of all Appointing Authorities under their Administrative control.
