The Committee will perform the following functions:

- 1) Monitor implementation of various welfare and other programme of TGs in the District.
- 2) Assist the State Level Transgender Welfare Board in the process of issue of I-Cards including the receipt of applications with self declaration from members of the transgender community.
- 3) Liaise with all Government Departments and agencies to ensure non-discrimination of TGs and ensure the full enjoyment of the rights of the transgenders.
- 4) Set up and monitor TG support and Crisis Intervention Centres on the model of Rape and crisis intervention centres. The centre should undertake counselling programmes and mental health issues that disproportionately affect the TG communities. The centre should also function as an information centre and support centre for TG persons. In case of any typical case, the District Level Transgender Welfare Committee shall refer the matter to the State Level Transgender Welfare Board.
- 5) Organize awareness campaigns to sensitize the general public and public official about the rights and privileges of transgenders.
- 6) Submit formal proposals for taking up schemes within the Policy framework to the TSU for consideration.
