Functions Of District Level Committee for Transgender :

- Monitor implementation of various welfare and other programmes of TGs in the districts.
- Assist the State Level Transgender Welfare Board in the process of issues of I- Cards including in the receipt of applications with self declaration from members of the transgender community.
- Liaise with all government departments and agencies to ensure non- discrimination of TGs and ensure the full enjoyment of the rights of the transgender.

Level Transgender Welfare Committee shall refer the matter to the State Level Transgender Welfare Board.

- Organize awareness campaigns to sensitize the general public and the public officials about the rights and privileges.
- Submit formal proposals for taking up schemes within the Policy framework to the TSU for consideration.
